With reference to your RTI, RTI/UNI/213 dated 14th October 2019 and appellate Authority reference no. RTI/UNI/FAA/713, it is stated that information sought by you are available in the university website <u>https://www.adtu.in/</u>. However, you are also intimated according to Points sought by you as under-

Point no. 1: Assam down town University was formed by Assam Legislative Assembly, Govt. of Assam in the year 2010 (Assam Govt. Notification No.LGL.9/2010/11 as a State Private University under section 6 of the Assam Private University Act, 2007 (ASSAM ACT NO.VIII OF 2010).

Assam down town University is recognized by University Grants Commission (UGC) under section 22 of the UGC ACT 1956. The degrees awarded are recognized by the UGC. Assam down town University is a fully fledged state private university and not a deemed university.

Assam down town University is duly affiliated to AICTE and programmes under Engineering, Management and Pharmacy are conducted under the purview of AICTE.

Pharmacy programmes at Assam down town University are approved by Pharmacy Council of India (PCI), a statutory body of Government of India established to regulate the Pharmacy Education in the Country for the purpose of registration as a pharmacist under the Pharmacy Act and Profession and Practice of Pharmacy.

Nursing programmes at Assam down town University are approved by the Indian Nursing Council(INC).

The University is maintaining the SIRO Certificates by Department of Scientific and Industrial Research (DSIR), Ministry of Science & Technology, Govt. of India.

Assam down town University is a NAAC accredited Grade-B University.

Assam down town University is ISO 9001:2015 certified for Higher Educational Services and Accredited by UKAS.

Point no. 2: Assam down town University provides **BPL scholarship, Entry level scholarship, Result Scholarship, Merit Scholarship, Sports and Extra Curricular Scholarships and** it is applicable to all the states including Jammu and Kashmir. Government scholarships are governed by the terms and conditions of the department concerned.

Point no. 3: BPL scholarship awarded to the meritorious students belonging to BPL. 50 seats are reserved every year absolutely free of cost for the students from the economically weaker sections of the society and preferably BPL students. These students will be eligible for 100% Admission Fee and Tuition Fee waiver. This is applicable to all the communities including Minority Communities. Government scholarships are governed by the terms and conditions of the department concerned.

Point no. 4: Admission Criteria for the students from Jammu and Kashmir are as per the norms prescribed by MHRD/ UGC.
