## MADHYA PRADESH ACT

No. 5 OF 2017

**THE MADHYA PRADESH NIJI VISHWAVIDYALAYA (STHAPANA AVAM SANCHALAN) TRITIYA SANSHODHAN ADHINIYAM, 2016.**

[Received the assent of the Governor on the 8<sup>th</sup> January, 2017; assent first published in the "Madhya Pradesh Gazette (Extra-ordinary)", dated the 12<sup>th</sup> January, 2017.]

**An Act further to amend the Madhya Pradesh Niji Vishwavidyalaya ( Sthapana Avam Sanchalan) Adhiniyam, 2007.**

Be it enacted by the Madhya Pradesh Legislature in the sixty-seventh year of the Republic of India as follows:—

1. This Act may be called the Madhya Pradesh Niji Vishwavidyalaya ( Sthapana Avam Sanchalan) Tritiya Sanshodhan Adhiniyam, 2016. Short title.

2. In Schedule to the Madhya Pradesh Niji Vishwavidhyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 ( No. 17 of 2007 ), after serial number 23 and entries relating thereto, the following serial number and entries relating thereto shall be added, namely :— Amendment of Schedule.

## Annexure-2 Name and List of Scholarship Schemes

Details of Avantika Scholarships (Applicable for all)

### 1) VED VYAS SCHOLARSHIP

This is a merit-based scholarship applicable to students who have secured top three positions in 12th standard in their respective boards (CBSE/ ISC/ State Boards) and students who have taken JEE (Mains). The scholarships are awarded depending upon the score secured in the examination.

A) Board Toppers

Sr. No.	Rank	Scholarship
1	First	100% of Tuition Fee
2	Second	75% of Tuition Fee
3	Third	50% of Tuition Fee

B) Merit in JEE

Sr. No.	All India Rank	Scholarship
1	Upto 25000	100% of Tuition Fee.
2	Upto 25000 to 35000	75% of Tuition Fee.
3	Upto 35000 to 45000	50% of Tuition Fee.

- The application form should be supported with qualifying examination certificates.
- This scholarship will not cover the other expenses such as hostel accommodation, mess, books, etc.

### 2) VIKRAM SCHOLARSHIP

This is a merit-cum-means scholarship applicable to students who have secured minimum 90% marks (PCM) or 80% marks (Arts/ Commerce) in 12th standard in the respective boards (CBSE/ ISC/ State Boards). The quantum of scholarship shall be determined based on annual income of parents.

Sr. No.	Annual income of parents	Scholarship
1	Upto Rs. 4 lakhs	100% of Tuition Fee.
2	Rs. 4 lakhs to Rs. 6 lakhs	75% of Tuition Fee.
3	Rs. 6 lakhs to Rs. 8 lakhs	50% of Tuition Fee.
4	Rs. 8 lakhs to Rs. 10 lakhs	25% of Tuition Fee.





- The application form should be supported with appropriate certificates.
- The necessary documents showing the income statements of the family members/ guardians and bank statement for last six months should be submitted.
- This scholarship will not cover the other expenses such as mess, hostel accommodation, books, etc.

### 3) ARJUN SCHOLARSHIP

This is a sports scholarship applicable to students who have participated and won medal/s at national and international level.

Sr. No.	Category	Scholarship
1	Won medal/s in International Championships	50% of Tuition Fee.
2	Won medal/s in National tournaments	35% of Tuition Fee.
3	Participated in the International Championship	25% of Tuition Fee.
4	Participated in National Tournaments	15% of Tuition Fee.

- The scholarship application must be supported with relevant certificates.
- The sport must be recognized by Indian Olympic Council (IOC)
- This scholarship will not cover the other expenses such as mess, hostel accommodation, books, etc.

### 4) CHANAKYA SCHOLARSHIP

This is a teaching assistance scheme applicable to students who have demonstrated excellent academic performance and are desirous of contributing to the university. The student is expected to contribute a specific number of hours per week and per month in assisting teaching and development activities of the university.

1	20	6,000
2	30	9,000
3	40	12,000

- The selection of students as teaching assistant will be the sole prerogative of the concerned Dean, on recommendation of Faculty Members.

### 5) ARYABHATA SCHOLARSHIP

This is a research assistance scheme applicable to students who have demonstrated excellent academic performance and are desirous of contributing to the university. The student is expected to contribute a





specific number of hours per week and per month in assisting the research and development activities of the university.

Sr. No.	No. of hours per month	Stipend
1	20	6,000
2	30	9,000
3	40	12,000

- The selection of students as research assistant will be the sole prerogative of the concerned Dean, on recommendation of Faculty Members.

#### 6) SUDAMA SCHOLARSHIP

This is a need-based, earn-and-learn scheme applicable to students who are desirous of contributing to the university in some way and wish to earn to support their education. The student is expected to contribute a specific number of hours per week and per month in assisting the research and development activities of the university.

Sr. No.	No. of hours per month	Stipend
1	20	6,000
2	30	9,000

- The selection of students will be the sole prerogative of the university and depend on quantum of work load.

#### 7) ASHOKA SCHOLARSHIP

This is a performance-based scholarship applicable to students who have demonstrated extraordinary performance during the academic year. This scholarship will be awarded based on the overall performance of students in various activities along with academic excellence.
