For B.Tech (CSE/MECH/Civil/EEE/EE/ECE/Aerospace/CSE-IBM/ CSE-AWS/MECH-DS)

i) Passed 10+2 examination with Physics, Mathematics along with one of the Chemistry/ Biotechnology/ Biology/Technical Vocational subject. Obtained at least 45% marks (40% in case of candidates belonging to reserved category) in the above subjects taken together. **OR** Passed Diploma (in Engineering and Technology) examination with at least 45% marks (40% in case of candidates belonging to reserved category)

- ii) The candidate must have to produce CLC / Conduct / Migration Original Certificate and other supportive documents
- iii) He must be a rank holder of our university entrance examination (CUEE)/JEE Main/EAMCET/WBJEE/other equivalent entrance test.

For BSC Agriculture: Candidate must have passed 10+2 Science or an equivalent examination conducted by any recognized board of education with PCB/PCMB/Agriculture having 60% aggregate. Admission based on the entrance test of University CUEE/ICAR/ OUAT.



For BFsc: Candidate must have passed 10+2 Science or an equivalent examination conducted by any recognized board of education with PCB/PCMB/Agriculture having 50% aggregate. Admission based on the entrance test of University CUEE/ICAR/ OUAT.

Other BSC Hons: Candidate must have passed 10+2 Science Phy,Chemstry/Biology and English as compulsory subject with minimum aggregate of 50% Score

For B.COM/BEA: Candidate must have passed 10+2 Arts/Science/Commerce with minimum aggregate of 50% Score or its equivalent examination conducted by any recognized board of education.

For BA: Candidate must have passed 10+2 or its equivalent examination conducted by any recognized board of education with minimum aggregate of 50% Score

For Diploma: Passed 10th Std./ SSC examination. Obtained at least 35% marks in the qualifying examination conducted by any recognized state board of education or quivalent.

For M.Tech: Candidate must be an engineering graduate, MCA, Msc (IT/CSE) Admission through GATE or any other equivalent entrance test or appropriate experience / merit.

For MBA: Candidate must be a graduate in any stream or its equivalent examination conducted by any recognized university/institution, Admission based on CUEE or any other national level entrance test.

For Msc Ag: (Bsc Ag/Horticulture) of 4Year duration with a minimum aggregate of 50% and based on entrance JRF/CUEE .
