- a. Relaxation in cut off percentage up to 10% subject to minimum eligibility requirement.
- b. Increase in intake capacity up to 5% course wise.
- c. Reservation of at least one seat in merit quota in technical/ professional institutions.
- d. Waiving of domicile requirements.
