Dear sir,

This is with reference to your letter No. RTI/UNI/313 dated 14/10/2019, seeking information under RTI Act, which was received in PIO, Sarala Birla University office on 21/10/19 regarding information related with admission in our university in various courses. In this regard, pointwise reply of queries raised in RTI is provided as under:

1. Sarala Birla University is a self-financed private university approved by state government and UGC. The Sarala Birla University Act. 2017 (Jharkhand Act. 13, 2017) has been passed by the Legislative Assembly of Jharkhand in 2017. The Sarala Birla University Act 2017 has been published in the Jharkhand Gazette on 4th July vide the Law Department Notification No. 504 dated 4th July 2017. For reference Annexure-1 is attached.
2. SBU provide financial support to students through e-kalyan, Govt. of Jharkhand for SC, ST and OBC students.

biology or any technical vocational subjects as optional with a minimum of 50% marks (45% in case of SC/ST category).

For BBA&BA courses: Pass 10+2 (any stream) or equivalent with a minimum of 50% marks in aggregate (45% in case of SC/ST category).

For MCA Course: Pass Bachelor' degree BCA/B.Sc. with mathematics/statistics/computer science/IT/Electronics with 55% marks. 5% relaxation for SC/ST/OBC/specially abled candidates.

For MBA course: Pass graduation from any stream with a minimum of 50% marks in aggregate (45% in case of SC/ST category).

For MA/M.Sc. in yoga course: Pass graduation from any stream with a minimum of 45% marks in aggregate (40% in case of SC/ST category).

For Diploma in yoga course: Pass 10+2 examination in any relevant stream.

Besides fulfilling above criteria, candidates need to clear SBUJEE entrance test conducted by Sarala Birla University for Engineering, diploma and MBA courses.

**Subject: Concession for the wards of Kashmiri Migrants and Kashmiri Pandit / Kashmiri Hindu Families (Non-Migrants) living in Kashmir valley for admission in Higher Educational Institutions - Regarding.**

Sir/Madam,

Attention is invited to this Ministry's letters No. 3-1/2012-NER dated 12.03.2015 and 22.07.2016 regarding certain concessions for the wards of Kashmiri migrants for their admission in Higher Education institutions in other parts of the country.


2. In this connection, representations have been received from Kashmiri Pandits (Non-Migrants) living in the Kashmir Valley to extend the existing concessions being provided to Kashmiri Migrants for them also.

3. The matter has been considered in this Department in consultation with Ministry of Home Affairs and State Government of Jammu & Kashmir. Now, it has been decided to allow the following concessions to the wards of Kashmiri Migrants as well as Kashmiri Pandits/ Kashmiri Hindu Families (Non-Migrants) who are living in the Kashmir Valley, in the matter of their admission in the educational institutions in other parts of the country from the academic year 2020-21 and onwards till further orders:

- (i) Relaxation in cut-off percentage upto 10% subject to minimum eligibility requirement.
- (ii) Increase in intake capacity upto 5% course-wise.
- (iii) Reservation of at least one seat in merit quota in technical/professional institutions.
- (iv) Waiving off domicile requirements for Kashmiri Migrants only. Kashmiri Pandits/Kashmiri Hindu Families (Non-Migrants) living in the Kashmiri Valley need domicile certificate.

4. This issues with the approval of Hon'ble HRM.
