How to apply

Candidates who have studied in Regular, Full time and Formal Education are only eligible to apply

Programmes Offered	Eligibility Criteria
B.Tech	 VITEEE Rank Holders (Ranks ranging from 1 to 1,50,000) with an aggregate of 60% in Physics, Chemistry, and Mathematics/ Biology in the qualifying examination (+2/Intermediate). Non VITEEE candidates with an aggregate of 70% in Physics, Chemistry, and Mathematics/ Biology in the qualifying examination (+2/Intermediate).
BBA B.Com	A pass in Higher Secondary Examination conducted by the State / Central Board of Secondary Education or its equivalent examination, with minimum of 60% overall aggregate. Students must have studied Commerce / Accountancy / Mathematics as one of the subjects.
B.Sc (Computer Science – Specialisation in Data Analytics)	A pass in any stream with Mathematics as one of the subjects with minimum of 60% overall aggregate in Higher Secondary examination conducted by the State/Central Board of Secondary Education or its equivalent examination.
MCA (Master of Computer Applications)	VITMEEE Rank Holders /Non VITMEEE candidates with a recognized Bachelor's Degree of Minimum 3 Yrs duration in BCA, B.Sc (IT/Computer Science) with Mathematics as a course at 10+2 level or at Graduate Level. Obtained at least 60% or first class in the qualifying Examination.
M.Tech. CSE (Specialization in Cyber Security & Digital Forensics)	VITMEEE Rank Holders /Non VITMEEE candidates with B.E/B.Tech. Degree in any branch / M.S / M.Sc. Computer Science or IT or Software Engineering/ MCA or any other equivalent degree from any recognized University with a minimum aggregate of 60% marks.
